▶ Pay taxes with EFTPS via the Internet or Phone.

- Secure
- Easy to use
- Accurate
- Receive immediate confirmation of all transactions
- Access 16 months of payment history
- Taxpayer in control of initiating all payments

▶ Use EFTPS for all individual and business taxes, available 24/7.

Taxpayers wishing to use EFTPS can enroll online or complete a paper enrollment form. Users are issued a PIN, and if they wish to make secure payments over the Internet, they will need to obtain an Internet Password.

With EFTPS, tax payments can be scheduled up to 120 days in advance for businesses and 365 days in advance for individuals.

- ▶ If you're filing an individual tax return or related forms or schedules, use IRS *e-file* to electronically file Forms 1040, 1040A, 1040EZ, 1040ES or 4868.
- ▶ If you're filing a business tax return or related forms or schedules, use IRS *e-file* to electronically file Forms 940/941, 1041, 1065, or 1120, 1120S or Information Returns 1042S, 1098, 1099, 5498, 8027, W2G, QWF-4. In addition, Charities and Non-Profits may now *e-file* Forms 990/990-EZ, 1120-POL and extension Form 8868.
